**SUPER LOCATION!! GREAT AMENITIES!!** The 2019 Summer New Mexico Sheriffs' Association conference will be held at the Ruidoso Convention Center & MCM Elegante Lodge Hotel, Ruidoso, New Mexico. Golf Tournament on Monday Afternoon w/Sheriffs, Vendor Social w/Sheriffs and Department Heads at the MCM Elegante Monday night, Complimentary lunch Tuesday & Wednesday & an Old-Fashioned Sheriff's BBQ with all attendees on Tuesday evening.
